

Pursuant to Article 22 of the Law on Public-Private Partnership and Concessions (Official Gazette of the Republic of Serbia Nos. 88/2011, 15/2016 and 104/2016) and Articles 31, 57 and 60 of the Public Procurement Law ("Official Gazette RS" Nos. 124/2012, 14/2015, 68/2015), hereinafter referred to as: "Law"), the Republic of Serbia, the Autonomous Province of Vojvodina, the Municipality of Irig - the President of Municipality of Irig publishes the following:

CALL FOR TENDERS

PUBLIC PROCUREMENT IN OPEN PROCEDURE FOR SELECTION OF PRIVATE PARTNER AND PUBLIC CONTRACT AWARD FOR PUBLIC PUBLIC-PRIVATE PARTNERSHIP WITHOUT ELEMENTS OF CONCESSION FOR RECONSTRUCTION, RATIONALISATION AND MAINTENANCE OF PUBLIC LIGHTING IN INHABITED PLACES OF IRIG MUNICIPALITY

Type of the public procurement procedure: **Open procedure**

Subject of public procurement in open procedure No. JN. 01-404-12/2018 is selection of private partner and contract award for public private partnership for reconstruction, rationalisation and maintenance of public lighting in inhabited places of Irig Municipality.

Type of subject: Services

The subject of procurement according to the Common Procurement Vocabulary is:

- 71314200 - Energy-management services
- 71314300 - Energy-efficiency consultancy services
- 50232100 - Street-lighting maintenance services
- 50232110 - Commissioning of public lighting installations
- 45316000 - Installation work of illumination and signalling systems.

The energy service subject of the public procurement is classified in the Supplementary Vocabulary in Division K (Residual attributes for energy and water distribution), Group A (Attributes for energy and water distribution) under:

- KA03 For electrical equipment
- KA04 For electrical installations

The subject of a public-private partnership contract without elements of concession is the implementation of measures aimed at a more efficient use of energy (hereinafter referred to as: MUE), adequate reduction of CO₂ emissions and reduction

of operating costs of a part of the PL System of the Municipality of Irig. The public call was published in the "Official Gazette of the Republic of Serbia" dated 22.03.2018.

Number of lots, if the subject of procurement is formed in multiple lots: The procurement is not formed in lots

Criterion, elements of the criterion for awarding contract:

The selection for the best bid will be done by applying the criterion of **the lowest price offered**- which is determined as **the highest offered net present value of the project**.

The tender documents are available: electronically, on the Public Procurement Portal at <http://portal.ujn.gov.rs> and Irig Municipality Portal at www.irig.rs – Public Procurement Folder.

Address and internet address of the state body or organisation, and/or the authority or service of territorial autonomy or local self-government where timely information on tax liabilities, environmental protection, employment protection, working conditions, etc. can be obtained:

Information on tax liabilities can be obtained from the Tax Administration, the Ministry of Finance and Economy.

Information on environmental protection can be obtained from the Environmental Protection Agency, the Ministry of Agriculture and Environmental Protection, and the Provincial Secretariat for Urban Planning, Construction and Environmental Protection of the AP Vojvodina.

Information on employment protection and working conditions can be obtained from the Ministry of Labour, Employment and Social Policy and the Provincial Secretariat for Economy, Employment and Gender Equality of the AP Vojvodina.

Data on fulfilment of occupational health and safety conditions can be obtained from the competent Labour Inspectorate.

Method of bid submission and deadline for bid submission:

The bidder submits its bid its bid directly or by mail in a sealed envelope or box, sealed in such manner that during bid opening it can be determined with certainty that it is being opened for the first time.

Bids are to be delivered to the following address: Republic of Serbia - Autonomous Province of Vojvodina, Municipality of Irig, Street Vojvode Putnika No. 1, 22406 Irig, with notice: "**Bid in open public procurement procedure No. JN. 01-404-12/2018 for selection of private partner and contract award for public private partnership for reconstruction, rationalisation and maintenance of public lighting in inhabited places of Irig Municipality – DO NOT OPEN**". Bids are to be delivered within 52 days from the day of the publication of the public call for tender on the "Public Procurement Portal", no later than 11 am on the day when the deadline for submission of bids expires.

In case of joint bid submission, it must be noted on the envelope that it is a joint bid and names and addresses of all participants in the joint bid must be stated.

Bid is considered to be timely if it is received by the Contracting Authority by 18.may.2018 no later than 11 am, regardless of the method of delivery.

If the last day for bid submission is a non-working day, the bid deadline expires on the following day at 11am. A bid submitted after the deadline for submission of bids shall be

considered untimely and shall be returned by the Public Procurement Committee to the bidder, sealed, with a notice that it has been untimely submitted.

Place, time and method of opening bids:

Public opening of bids shall be carried out upon expiry of 52 days from the day of publication of the Public call on the Public Procurement Portal (which means on the fifty-third day from the day of publication on the Public Procurement Portal), i.e. 18.may.2018 at 12pm, in the office of the Contracting Authority- Municipal Administration of the Municipality of Irig, Str. Vojvode Putnika No. 1, 22406 Irig.

Conditions of bidder's representative participation

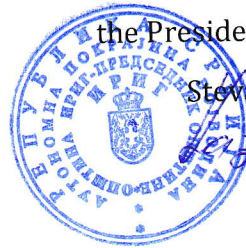
Only authorised representatives of bidders who must have the appropriate power of attorney to participate in the bid opening procedure, issued on the bidder's memorandum, signed and authenticated may be actively involved in the procedure of opening bids.

Deadline for reaching a decision:

A decision about the selection of the best bid shall be reached within 60 days from the day of bid opening.
